5	DAY NURSERY PARKING 1 STALL ON SITE IN LIEU OF 11.23 STALLS REQUIRED.
6	RESIDENT PARKING 32 STALLS ON SITE IN LIEU OF 48 STALLS REQUIRED.

ALTERNATIVE EQUIVALENT COMPLIANCE FOR THE PROPOSED YARD VARIANCES (1 AND 2) THE SOUTH SIDE YARD LANDSCAPE BUFFER (3) WILL BE PROVIDED AS FOLLOWS:

A NORTH SIDE YARD. THE BALANCE OF THE SIDE YARD IS 3m AND WILL BE LANDSCAPED WITH A FENCE AND TREES. THE YARD ADJACENT TO THE BUILDING IS 3m.

SOUTH SIDE YARD. THE PROPOSED 1.2m YARD TO PARKING AND 1.5m YARD TO SIDEWALK WILL BE LANDSCAPED WITH A FENCE AND TREES PROVIDING THE REQUIRED CONTINUOUS LANDSCAPED BUFFER STRIP. THE YARD ADJACENT TO THE BUILDING IS 3m.

C MINNESOTA STREET CONTINUOUS LANDSCAPE BUFFER STRIP WITH AVERAGE WIDTH OF 3m WILL BE PROVIDED WITHIN THE ADJACENT PUBLIC BOULEVARD THAT IS ±5m WIDER THAN STANDARD BOULEVARD WIDTH.
