Section 53 of the Planning Act, RSO 1990

**TAKE NOTICE** that the City of Kenora Committee of Adjustment (COA) will hold a regular meeting on August 20<sup>th</sup>, 2025, at 6 p.m.

As part of the meeting, the Committee will consider a proposed Consent under Section 53 of the Planning Act (RSO 1990), as described below and shown on the attached map.

LOCATION: 360 & 414 Coney Island

### **PURPOSE AND EFFECT**

The purpose of the consent application is for lot additions to correct encroachments of accessory structures.

The application proposes to sever 0.006 hectares of land from 414 Coney Island to be consolidated with 360 Coney Island. As well as severing 0.052 hectares of land from 360 Coney Island to be consolidated with 414 Coney Island. Please see key map below. The subject lands are designated Rural Area in the City's Official Plan and zoned 'RR' Rural Residential Zone in the City's Zoning By-law.

An application for Minor Variance (File No. D13-25-12) under Section 45 of the Planning Act, has been applied for concurrently, to reduce the minimum lot area of 360 Coney Island.
